

**TOWNSHIP OF WEST BRADFORD
RESOLUTION 10-21**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF WEST BRADFORD TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, AUTHORIZING, EMPOWERING AND DIRECTING THE PROPER OFFICERS OF THE TOWNSHIP TO EXECUTE AN AGREEMENT WHEREUNDER KEYSTONE COLLECTIONS GROUP IS RETAINED AS THE EXCLUSIVE TAX OFFICER FOR THE COLLECTION, ADMINISTRATION, RECEIPT AND ENFORCEMENT OF THE PROVISIONS OF THE RESPECTIVE TAX ENACTMENT OF THE BOARD OF SUPERVISORS LEVYING AND ASSESSING THE EARNED INCOME TAX FOR THE TERM HEREIN DEFINED, TOGETHER WITH SUCH EXTENSIONS AS MAY BE AGREED UPON, SAID TAX ENACTMENT HAVING BEEN ADOPTED UNDER AND PURSUANT TO THE AUTHORITY OF THE PENNSYLVANIA LOCAL TAX ENABLING ACT NO. 32 ., § 515 (b), 53 P.S. § 6924.515(b), AND OTHER APPLICABLE LAW; AND APPROVING AND ADOPTING THE RULES AND REGULATIONS PREPARED BY KEYSTONE COLLECTIONS GROUP TO ADMINISTER AND ENFORCE THE EARNED INCOME/NET PROFITS TAX.

WHEREAS, under the authority of the Local Tax Enabling Act No. 32 of 2008 § 515 (b), 53 P.S. § 6924.515(b), which requires that WEST BRADFORD TOWNSHIP, CHESTER COUNTY appoint the tax collector that is appointed by and under master contract with the Chester Tax Collections Committee; and

WHEREAS, WEST BRADFORD TOWNSHIP, CHESTER COUNTY, by Ordinance 10-02, has levied, assessed and provided for the collection of such Earned Income Tax; and

WHEREAS, WEST BRADFORD TOWNSHIP, CHESTER COUNTY, and Keystone Collections Group have negotiated an Agreement through the Chester Tax Collection District; whereby and whereunder the Township will hire Keystone Collections Group to collect the Earned Income Tax levied by the WEST BRADFORD TOWNSHIP, CHESTER COUNTY, and

WHEREAS, WEST BRADFORD TOWNSHIP, CHESTER COUNTY, recognizes the legal obligation and practical necessity for Keystone Collections Group to establish and maintain consistent rules and regulations to be used in the efficient administration and collection of said taxes;

THEREFORE, BE IT RESOLVED that


- 1. WEST BRADFORD TOWNSHIP, CHESTER COUNTY hereby appoints KEYSTONE COLLECTIONS GROUP (the tax collector appointed by and under master contract with the Tax Collections Committee) as its exclusive collector of its EARNED INCOME TAXES for 2011 term, commencing January 1, 2011 and ending December 31, 2011, and any subsequent renewal terms thereafter, said initial and renewal periods to include all quarterly and annual collections pertinent to the tax years therein. This appointment***

resolution shall be deemed to encompass any renewal terms agreed upon by the parties without further reenactment of this resolution or reappointment.

2. Further, **KEYSTONE COLLECTIONS GROUP** is authorized to retain any costs of collection incurred in recovering delinquent taxes and assessed to the delinquent taxpayer as allowed by law.
3. And further, **WEST BRADFORD TOWNSHIP, CHESTER COUNTY APPROVES AND ADOPTS** the Agreement negotiated with Keystone Collections Group for the collection of the **EARNED INCOME TAX**.
4. And further, **WEST BRADFORD TOWNSHIP, CHESTER COUNTY** adopts and incorporates the **Earned Income Tax Rules and Regulations** as promulgated by Keystone Collections Group, in their entirety.
5. Any resolution or part of this resolution conflicting with the provisions of this resolution be and the same are hereby repealed to the extent of such conflict.


