ALL OF WHICH ARE LOCATED IN CHESTER COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF INITIALLY ENTERING INTO AN AGREEMENT WITH LEGAL COUNSEL TO NEGOTIATE WITH VERIZON FOR A FRANCHISE AGREEMENT AND FOR ANY OTHER PURPOSE DEEMED NECESSARY AND BENEFICIAL BY THE MUNICIPALITY.

West Bradford Township, Chester County, Pennsylvania, hereby ordains as follows:


1. The Board of Supervisors authorizes the proper officers of West Bradford Township to enter into the Intergovernmental Cooperation Agreement with any or all of the aforementioned municipalities.
2. The aforesaid agreement shall continue until revoked by action(s) by each respective municipality participating in said agreement.
3. The purpose and objective of the agreement is to facilitate proposals, agreements, cooperative actions and to promote the health, safety and welfare of the participating municipalities with the least expenditure on behalf of the participating municipalities.

4. The agreement shall be financed by the use of proper funds of the participating Municipalities.
5. Each Municipality shall designate a representative to implement the agreement.




