A RESOLUTION TO PURCHASE A VEHICLE UNDER THE ACT OF ASSEMBLY  
OF THE COMMONWEALTH OF PENNSYLVANIA (ACT 31)  
AUTHORIZING SUCH PURCHASES.

BE IT AND IT IS HEREBY RESOLVED, BY THE BOARD OF SUPERVISORS  
OF WEST BRADFORD TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA:

WHEREAS, THE TOWNSHIP OF WEST BRADFORD IS IN NEED OF AN  
ADDITIONAL VEHICLE FOR GENERAL ADMINISTRATIVE PURPOSES; AND

WHEREAS, SAID ACT 31 FURTHER PROVIDES THE TERMS AND  
PROCEDURES FOR EFFECTUATING THE SAME; AND

WHEREAS, UNDER AND BY VIRTUE OF SAID ACT 31, THE SAID POLITICAL  
SUBDIVISION IS THEREBY EXEMPTED FROM EXISTING STATUTORY REQUIREMENTS  
GOVERNING COMPETITIVE BIDDING AND EXECUTION OF CONTRACTS WITH  
RESPECT TO THE PURCHASE OF EQUIPMENT UNDER THAT SECTION; AND

WHEREAS, THE SAID POLITICAL SUBDIVISION ADOPTED A RESOLUTION  
ON FEBRUARY 8, 1972, TO TAKE PART IN THIS PROGRAM.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF SUPERVISORS  
OF WEST BRADFORD TOWNSHIP DO HEREBY AUTHORIZE THE PURCHASE, THROUGH  
THE DEPARTMENT OF GENERAL SERVICES, BUREAU OF PROPERTY AND SUPPLIES  
OF THE COMMONWEALTH OF PENNSYLVANIA, ONE 4 X 4, ONE-HALF TON,  
4 WHEEL DRIVE, STATION-WAGON TYPE TRUCK, FROM STATE VENDOR #31205,  
MT. POCONO AMC/JEEP, AS PER ATTACHED SPECIFICATION, FOR THE SUM  
TOTAL OF \$4978.50.
