**A RESOLUTION OF THE TOWNSHIP OF WEST BRADFORD, CHESTER COUNTY, COMMONWEALTH OF PENNSYLVANIA, DECLARING CERTAIN SURPLUS ASSETS AND AUTHORIZING THE SALE OF SAID ASSETS BY PUBLIC AUCTION.**

**WHEREAS**, The Board of Supervisors of the Township of West Bradford is authorized by the Second Class Township Code, Act of May 1, 1933 - P.L. 103, No. 69, as amended, to dispose of personal property by public bid or auction and;

**WHEREAS**, by authority of the Intergovernmental Cooperation Act, Act 180 of 1972, as amended, the Board of Supervisors of the Township of West Bradford may delegate any function or responsibility to another governmental unit or political subdivision and;

**WHEREAS**, the Township of West Bradford has entered into an intergovernmental agreement with other political subdivisions collectively known as the **Chester County Consortium of Municipal Managers** for the purpose of fostering cooperative efforts in resolving problems, developing policies and undertaking projects of mutual benefit;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the Township of West Bradford that the following items of personal property are declared as surplus property and are authorized to be sold at public auction:




