**KEYSTONE RECREATION, PARK AND CONSERVATION FUND
ACQUISITION AND DEVELOPMENT GRANT PROGRAMS RESOLUTION**

WHEREAS Act 1993-50, the Keystone Recreation, Park and Conservation Fund Act, authorized the Department of Community Affairs (DCA) and the Department of Environmental Resources (DER) to provide grant funds for various park, recreation, and conservation facility projects; and

WHEREAS, Act of 1995-18, the Conservation and Natural Resources Act, created the new Department of Conservation and Natural Resources (DCNR) and transferred the Bureau of Recreation and Conservation and its programs from DCA to DCNR; and transferred the Rails-to-Trails and Rivers Conservation Grant programs from DER to DCNR; and

WHEREAS THE TOWNSHIP OF WEST BRADFORD desires to
