

**TOWNSHIP OF WEST BRADFORD
RESOLUTION 97-01**

EMERGENCY SERVICES RESPONSE AREAS

WHEREAS, the Board of Supervisors of West Bradford Township are responsible under the Second Class Township Code for the public safety of the residents of West Bradford Township; and

WHEREAS, the Board of Commissioners of the County of Chester has requested that West Bradford Township provide the Board of Commissioners with a Resolution outlining the methods and agencies chosen to fulfill the public safety needs of West Bradford Township for the efficient administration of the emergency communications system of the Chester County Department of Emergency Services;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED that the West Bradford Fire Company will provide fire protection and rescue service;


FURTHER, BE IT RESOLVED THAT the Good Fellowship Ambulance of West Chester, Modena Ambulance, and the Minquas Ambulance of Downingtown will provide ambulance service;

FURTHER, BE IT RESOLVED THAT the State Police, Embreeville Barracks will provide police protection.

The contact person between West Bradford Township and the Chester County Department of Emergency Services shall be the Chief of the West Bradford Fire Company.



THE BOUNDARIES FOR FIRE PROTECTION WILL BE:

WEST BRADFORD FIRE COMPANY:

Entire township.

THE BOUNDARIES FOR AMBULANCE SERVICE WILL BE:

GOOD FELLOWSHIP AMBULANCE CLUB:

South of Shadyside Road, not including Shadyside Road and east of, but not including Romansville Road.

MINQUAS AMBULANCE CLUB:

North of and including Shadyside Road, east of, but not including Broad Run Road, and east to Downingtown.

MODENA AMBULANCE CLUB:

Including Romansville Road and Broad Run Road, west to the Township Line.

THE BOUNDARIES FOR RESCUE SERVICE WILL BE:

WEST BRADFORD FIRE COMPANY:

Entire Township.

THE BOUNDARIES FOR POLICE PROTECTION WILL BE:

EMBREEVILLE STATE POLICE:

Entire Township.

THE BOUNDARIES FOR ADVANCED LIFE SUPPORT SHALL BE:

MEDIC 91:

Covering those areas served by the Good Fellowship Ambulance.

MEDIC 93:

Covering those areas served by the Minquas Ambulance and the Modena Ambulance.
