RESOLUTION 00-13**

A RESOLUTION APPOINTING GARY O. SCHMIDT, PARKS DIRECTOR, AS DESIGNATED AGENT FOR SECURING STATE AND COUNTY FUNDING FOR THE DEVELOPMENT OF SHADYSIDE PARK ON BEHALF OF THE WEST BRADFORD TOWNSHIP BOARD OF SUPERVISORS

WHEREAS, the West Bradford Township Board of Supervisors adopted the Shadyside Park Master Plan on September 26, 2000 and intend to develop the park as indicated in the Plan; and

WHEREAS, the Board of Supervisors desires to secure and intends to avail itself of outside grants and other funding sources to develop facilities at the park.

WHEREAS, the Board of Supervisors desires to apply to the Department of Conservation and Natural Resources ("Department") for a grant for the purpose of carrying out this project; and

WHEREAS, the application package includes a document entitled "Terms and Conditions of Grant" and a document entitled "Signature Page for Grant application and Grant Agreement"; and

WHEREAS, the Board of Supervisors understands that the contents of the document entitled "Terms and Conditions of Grant," including appendices referred to therein, will become the terms and conditions of a Grant Agreement between the applicant and the Department if the Township of West Bradford is awarded a grant; and

WHEREAS, the Board of Supervisors understands that, by signing the "Signature Page for Grant Application and Grant Agreement" and submitting it to the Department as part of the grant application, the Board of Supervisors agrees to the terms and conditions of the grant and will be bound by the Grant Agreement if the Department awards a grant;

NOW, THEREFORE, be it and it is hereby RESOLVED by the Board of Supervisors of West Bradford Township, Chester County, as follows:

That Mr. Gary O. Schmidt, Parks Director, is hereby appointed as the designated Township agent on behalf of the Board of Supervisors to secure grants and other funding sources to develop facilities at the park.


That Gary O. Schmidt, Parks Director, is authorized to sign the "Signature Page for Grant Application and Grant Agreement" on behalf of the applicant.

That if Gary O. Schmidt signed the "Signature Page for Grant application and Grant Agreement" prior to the passage of this Resolution, this grant of authority applies retroactively to the date of signing.



Schmidt will become the Township of West Bradford's executed signature page for the Grant Agreement, and the applicant/grantee will be bound by the Grant Agreement.


