Mr. Cook motioned to approve the February 7, 2017 Planning Commission meeting minutes, second by Mr. Parker. All ayes, motion carried 4-0.

SUBDIVISIONS:

<u>2016-05</u> Donnon – 1501 Glenside Road – 3 Lots – Preliminary/Final

Mark Padula of Inland Design presented the plans on behalf of Mrs. Lisa Donnon. Mr. Slouf questioned the trees to be removed and if new trees would be planted to offset the ones being cut. Mrs. Donnon stated that she planned to save as many of the trees as possible. The Commission also discussed the private road and the need for clarification if the road is to be 12 feet wide through the first two lots or 16 feet. Township Manager will clarify that with Engineer Ted Gacomis. Mr. Slouf also noted that a waiver may be required for the single driveway serving three lots. No additional action was taken.

<u>2016-04 B. Ross Capps Minor Subdivision – 205 N. Wawaset Road – 2 Lots – Final</u> Barry Walsh from E.B. Walsh presented the plans on behalf of the applicant. Mr. Walsh explained the annexation and the open run horse stall on the property being acquired.

Mr. Slouf motioned to recommend conditional final approval based upon a note affixed to the plan stating that the existing gate along the access road should not be construed as a formal driveway entrance and if in the future this is changed, it shall meet the West Bradford Township driveway ordinance requirements, second by Mr. Merva. All ayes, motion carried 4-0.
