#### Conditional Use Application based on Ordinance 19-07Accessory Suite

Accessory Suite – Brian McCarthy presented the application to the members on plans to construct an accessory suite within his basement. A general discussion took place. Mr. Slouf read aloud comments and questions from Mr. Merva, who was not in attendance as well as the responses from the Township Solicitor.

Mr. Slouf made a motion to recommend conditional approval based upon available parking and sewage availability as well as all other County and Township regulations be adhered to, second by Mr. Parker. All ayes, motion carried 5-0.

## Ordinance 21-04 Amending Section 450-9 of Township Code.

Michael Gill provided an overview of the amendments to the existing Township Code. Ordinance 21-04 amends one parcel on the zoning map from R-1 to I (parcel #50-1-69). This allows for daycare use, parking regulations as well as special events other than those currently permitted. A general discussion on the proposed changes took place.

The Commission took no action and will continue the discussion at their May 4, 2021 meeting.
