ORDINANCE NO. 24-01

AN ORDINANCE OF THE TOWNSHIP OF WEST BRADFORD, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 298 OF THE WEST BRADFORD TOWNSHIP CODE, TITLED "PEDDLING AND SOLICITING," TO AMEND SECTION 298-2 TITLED "APPLICATION FOR LICENSE" SUBPARAGRAPH B REGARDING THE REQUIRED DOCUMENTATION THAT MUST BE SUBMITTED TO THE TOWNSHIP AND TO AMEND SECTION 298-3 TITLED "RULES OF CONDUCT" TO ADD A NEW SUBPARAGRAPH F TO ESTABLISH REASONABLE TIME RESTRICTIONS FOR PEDDLING AND SOLICITING.

IT IS HEREBY ENACTED AND ORDAINED, by the Board of Supervisors of West Bradford Township, that Chapter 298 of the West Bradford Township Code, titled, "Peddling and Soliciting" shall be amended as follows:

**SECTION 1.** Section 298-2, titled "Application for license," subparagraph B shall be amended to read as follows:

"B. In addition to the application set forth in § 298-2A, the applicant shall submit the following to the Township Secretary:

- (1) A photograph;
- (2) A written description of the applicant;
- (3) A copy of the applicant's criminal history/record from the Pennsylvania State Police that was processed by the Pennsylvania State Police within 60 days of the date of the submission of the completed application;
- (4) A copy of the applicant's criminal history/record from the state police agency in any state where the applicant resided within the last 10 years which was processed by said state police agency within 60 days of the date of the submission of the completed application; and
- (5) The fee for such license as shall be established from time to time by resolution of the Township Board of Supervisors."

**SECTION 2.** Section 298-3, titled "Rules of conduct," shall be amended to add a new subparagraph F to read as follows:

"F. The licensee shall not engage in any business or activity authorized under this article except between the hours of 8:00 a.m., current prevailing time, and 9:00 p.m., current prevailing time, or sunset, whichever occurs earlier."

**SECTION 3. SEVERABILITY.** If any provision, sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part thereof not been included herein.


**SECTION 4. EFFECTIVE DATE.** This Ordinance shall become effective five days after enactment.


