**RESOLUTION 25-01**

**UPDATING DESIGNATED EMERGENCY SERVICES PROVIDERS  
FOR WEST BRADFORD TOWNSHIP**

**WHEREAS**, the Board of Supervisors of West Bradford Township is responsible under the Second Class Township Code for the public safety of the residents of West Bradford Township; and,

**WHEREAS**, the Board of Commissioners of the County of Chester has requested that West Bradford Township provide a Resolution outlining the methods and agencies chosen to fulfill the public safety needs of West Bradford Township so to assist in the efficient administration of the emergency communications system of the Chester County Department of Emergency Services.

**NOW, THEREFORE, BE IT RESOLVED** the West Bradford Fire Company will provide fire protection and chooses to use a combination of designated primary coverage area and the use of Automatic Vehicle Location services, as outlined in attached Exhibit A.

**FURTHER, BE IT RESOLVED** Good Fellowship Ambulance of West Chester, Modena Ambulance, and the Minquas Ambulance of Downingtown will provide ambulance service as outlined in attached Exhibit A; and

**FURTHER, BE IT RESOLVED** the Pennsylvania State Police, Embreeville Barracks, will provide full time police protection as outlined in attached Exhibit A; and

**FURTHER, BE IT RESOLVED** the West Bradford Fire Company will provide rescue service as outlined in attached Exhibit A; and,

**FURTHER, BE IT RESOLVED** that Good Fellowship Ambulance and Minquas Ambulance will provide Advanced Life Support services as outlined in attached Exhibit A; and


**FURTHER BE IT RESOLVED** that Dennis Dougherty is designated as Emergency Management Coordinator; and

**FURTHER, BE IT RESOLVED** that the Board of Supervisors and Emergency Management Coordinator have reviewed and revised, if necessary, and adopted the West Bradford Township Emergency Operations Plan; and has reviewed and adopted the National Incident Management System as a common operating practice.

**AND FURTHER, BE IT RESOLVED**, the contact person between West Bradford Township and the Chester County Department of Emergency Services shall be the Chief of West Bradford Fire Company.



EXHIBIT A

**THE BOUNDARIES FOR FIRE PROTECTION WILL BE:**

WEST BRADFORD FIRE COMPANY: Entire Township.

**THE BOUNDARIES FOR AMBULANCE SERVICE WILL BE:**

GOOD FELLOWSHIP AMBULANCE CLUB:

- South of Shadyside Road, not including Shadyside Road; AND,
- East of Stargazers Road, including Stargazers Road.

MINQUAS AMBULANCE CLUB:

- North of Shadyside Road, including Shadyside Road; AND,
- East of Broad Run Road, including Broad Run Road; AND,
- East of Embreeville Road, including Embreeville Road.

MODENA AMBULANCE CLUB:

- West of Embreeville Road, not including Embreeville Road; AND,
- West of Broad Run Road, not including Broad Run Road, to Shadyside Road; AND,
- North of Shadyside Road between Broad Run Road and West Strasburg Road, including Shadyside Road; AND,
- West of Stargazers Road, not including Stargazers Road.

**THE BOUNDARIES FOR RESCUE SERVICE WILL BE:**

WEST BRADFORD FIRE COMPANY: Entire Township.

**THE BOUNDARIES FOR POLICE PROTECTION WILL BE:**

EMBREEVILLE STATE POLICE: Entire Township.

**THE BOUNDARIES FOR ADVANCED LIFE SUPPORT WILL BE:**

Good Fellowship: Covering those areas served by the Good Fellowship Ambulance.

Minquas EMS: Covering those areas served by the Minquas Ambulance.

*\*ALS Coverage for those areas covered by Modena Ambulance:*

- \* \* Chestnut Lane and south – Good Fellowship ALS.
- \* \* North of Chestnut Lane – Minquas ALS.
- \* \* Second due cover ALS via AVL recommendation (all areas)

**THE BOUNDARIES FOR AIR AMBULANCE SERVICE WILL BE:**

Entire Township - The Chester County Department of Emergency Services shall assign the closest air ambulance service(s) as primary provider(s) within the Township as appropriate. In addition, the Department shall designate secondary air ambulance up to the fifth due in order of closest.
