# A. Public Hearing -Conservation Easement - Parcels #50-9-31 and #50-9-39

Mr. Houghton opened the public hearing to consider the purchase of a conservation easement across property located at 1522 and 1523 Camp Linden Rd. – Chester County Tax Parcels #50-9-31 and #50-9-39 owned by the Philadelphia Ethical Society.

Mr. Hines motioned to approve the purchase of a conservation easement in the amount of \$292,500.00 with an endowment in the amount of \$10,184.00, across property located at 1522 and 1523 Camp Linden Rd. – Chester County Tax Parcels #50-9-31 and #50-9-39 owned by the Philadelphia Ethical Society, second by Mrs. Abele. Motion carried 3-0.

## B. PA DEP TMDL – Presentation and Public Comment

Engineer Dan Daley presented the TMDL (total maximum daily load) and accepted public comment.

Miss Roberta Ekdahl 1751 W Strasburg Rd, West Chester, PA and Mr. John Merva 2048 Arrowhead Trail, Coatesville, PA both asked our engineer questions regarding the TMDL plan. Engineer Dan Daley gave a detailed explanation, answered questions related to the TMDL plan, and will incorporate comments into the Township's TMDL application.

Mr. Hines motioned to authorize Engineer Dan Daley to submit the plan to PA DEP, seconded by Mrs. Abele. Motion carried 3-0.

# C. Resolution 22-15 - Adding Properties to the Agricultural Security Area

Mrs. Abele motioned to adopt Resolution 22-15 adding certain properties to the agricultural security area, second by Mr. Hines. Motion carried 3-0.

# D. Resolution 22-16 – Multimodal Funding Request

Mrs. Abele motioned to adopt Resolution 22-16 authorizing the Township Manager to make the application for the 2023/2024 funding round in the amount of \$1,975,266.00, seconded by Mr. Hines. Motion carried 3-0.

### E. Disc Filter Replacement – Strasburg Corridor Wastewater Treatment Facility

Mr. Hines motioned to award the proposal/contract to Eastern Environmental Contractors for a replacement of the disc filter at Strasburg Wastewater Treatment Facility in the amount of \$270,710.00., second by Mrs. Abele. Motion carried 3-0

#### F. Public Works – New Hire

Mrs. Abele, motioned to approve the hiring of Edmund Johnson to the position of flex staff, Public Works Department subject to successful background investigation and six-month probationary period. Mr. Johnson will be an at-will employee., second by Mr. Hines. Motion carried 3-0
