Chairman Bruce Laverty called the meeting to order at 8:01 p.m.

Chairman Laverty announced that an Executive Session for litigation was held earlier in the day from 3:30 to 4:45 p.m.

- Mr. James Brown, 1109 Bent Oak Trail, spoke of stormwater issues. He is interested in resolving the runoff issue but seeks guidance from the Township. Township personnel will investigate.

MINUTES - FEBRUARY 9, 2016

Mr. Hines motioned to approve the February 9, 2016 Meeting Minutes as presented, second by Mr. Blair. All ayes, motion carried 3 - 0.

TREASURER'S REPORT

Mr. Kapp reported on fund activity for the year to date and presented a list of bills to be paid.

Mr. Blair motioned to pay the bills as presented, second by Mr. Hines. Let the record reflect Mr. Hines abstained from voting to pay the Brandywine Conservancy invoice as he is an Officer of the organization, motion carried 2-0-1.

Public Park AED's

Mr. Laverty motioned to approve acceptance of Whiffletree Lane and various easements of Tattersall Phase 5 for dedication. Second by Mr. Blair. All ayes, 3-0.

Resolution 16-07 – Honoring Mr. John A. Haiko

Mr. Blair motioned to approve this resolution honoring retired Supervisor Haiko for 27 years of dedicated service to West Bradford Township. Second by Mr. Hines. All ayes 3-0.

Resolution 16-08 – Dedication of Sanitary Sewer lines, Tattersall Phase 5 Development

Mr. Laverty motioned to approve acceptance of sanitary sewer lines and various easements of Tattersall Phase 5 for dedication. Second by Mr. Blair. All ayes 3-0.

Buck Hill Farm - Chestnut Lane

Mr. Hines questioned the language in the Dual Obligee Rider. The Board would like a better explanation of the language included. Chairman Laverty tabled discussion until further information is received.

Schorn Construction - 1232 Sawmill Road

Mr. Fran Schorn explained his letter requesting a waiver from land development procedure for an 800 square foot addition. Mr. Laverty motioned to approve this waiver. Second by Mr. Hines. All ayes 3-0.

SUBDIVISIONS

2015-03 Cook - 2 Lots - Final

Mr. Cook gave a presentation of his lot line adjustment. Mr. Hines motioned to grant approval, conditioned on the following:

- 1. Providing proof of notice to adjacent property owners to the Township.
- 2. Must show in the notes and on the plan where the property pins will be located.
- 3. Must provide notes on the plan listing the waivers requested from the West Bradford Township Subdivision and Land Develop Ordinance 2005.

Motion seconded by Mr. Laverty. All ayes 3-0.

2013-04 StargazerVillage @ Romansville – Final – 135 Units

In this addition to the meeting agenda, Mr. Bob Smiley presented his request to adjust some front load garages to side load, as well as adjusting some driveway layouts. The requests are detailed in Mr. Smiley's letter dated January 27, 2016. A general discussion took place.

Mr. Laverty motioned to grant the changes requested as outlined in Mr. Smiley's letter of January 27, 2016. Second by Mr. Blair. All ayes 3-0.
