BOARD OF SUPERVISORS

TOWNSHIP PERSONNEL

Mark J. Blair, Chairman Jack M. Hines, Jr., Vice Chairman William R. Christman, III, Member Justin Yaich, Township Manager Ron Youtz, Public Works Director

Chairman Mark J. Blair called the meeting to order at 8:00 p.m.

Chairman Blair announced that the Board met in executive session on December 12, 2017 from 6:30 p.m. to 7:30 p.m. to discuss litigation, real estate, and personnel.

Chairman Blair introduced Senator Andrew E. Dinniman who presented Chairman Blair with a Senate Resolution honoring his years of services. Mr. Blair was also presented with citations from Representative Eric Roe and Congressman Ryan Costello.

Chairman Blair announced that there would be one addition to the agenda which would include a motion to change the name of the Mayfair Subdivision to The Townes at Shannon Hill. Mr. Hines motioned to authorize the name change, second by Mr. Christman. Motion carried 3-0.

Mr. Blair opened the floor to public comment. There being no public comment, Mr. Blair closed the comment period.

Mr. Hines presented Mr. Blair with a clock from the Township honoring his years of service. Mr. Hines gave remarks on Mr. Blair's years of service. Mr. Christman echoed Mr. Hine's comments.

Mr. Blair opened the public hearing on the proposed Ordinance 17-07 at 8:20 p.m. Mr. Blair called for public comment. Hearing none, Mr. Blair motioned to close the public comment portion of the hearing at 8:22 p.m., second by Mr. Hines. Motion carried 3-0.

Ordinance 17-07

Mr. Hines recommended a minor edit to the wording to Section 3, paragraph D to state "Lands containing historic significance and existing or future pedestrian and equestrian trails" all other wording to remain intact. Mr. Blair motioned to adopted Ordinance 17-07, second by Mr. Christman. Motion carried 3-0.

<u>Public Hearing – Ordinance Authorizing the Imposition of an Additional Earned Income Tax at the Rate of One Quarter of One Percent to Raise Revenue to Purchase Interests in Real Estate or Making Acquisitions of Real Property for Purposes of Securing Open Space Benefits</u>

Mr. Blair opened the public hearing on the proposed Ordinance 17-08 at 8:24 p.m. Mr. Blair called for public comment. Hearing none, Mr. Blair motioned to close the public hearing at 8:25 p.m., second by Mr. Christman. Motion carried 3-0.

Ordinance 17-08

Mr. Hines motioned to adopt Ordinance 17-08, second by Mr. Christman. Motion carried 3-0.

Public Hearing – 2018 Budget

Mr. Blair opened the public hearing on the proposed 2018 budget. The Township Manager gave an overview of the 2018 highlights. Mr. Blair called for public comment. Hearing none, Mr. Blair motioned to close the public hearing at 8:30 p.m., second by Mr. Christman. Motion carried 3-0.

Resolution 17-16

Mr. Hines motioned to adopt Resolution 17-16, second by Mr. Christman. Motion carried 3-0.

Resolution 17-17

Mr. Christman motioned to adopt Resolution 17-17, second by Mr. Hines. Motion carried 3-0.

Resolution 17-18

Mr. Christman motioned to adopt Resolution 17-18, second by Mr. Blair. Motion carried 3-0.

Resolution 17-19

Mr. Blair commented on two changes he would like to recommend. First, the Committee may have a representative meet with landowners to explain the benefits of open space. Second, the committee may also designate a consultant who is not a member of the committee to attend such meetings. All of which should be in conjunction with the Township Manager.

Mr. Hines motioned to adopt Resolution 17-19 with the noted changes, second by Mr. Christman. Motion carried 3-0.

Municibid Award – 2010 Mack Refuse/Recycling Truck and 2000 Sterling Dump Truck

Mr. Christman motioned to award the sale of the 2010 Mack refuse/recycling truck to Whitetail Disposal of Gilbertsville, PA for the bid amount of \$35,800 and the 2000 Sterling dump truck to Stanley, LLC of Thurmont, MD for the bid amount of \$18,700, second by Mr. Hines. Motion carried 3-0.

Sale of 2011 Ford Explorer

Mr. Hines motioned to award the sale of the Codes Department vehicle to the Borough of Downingtown for the amount of \$9,000, second by Mr. Blair. Motion carried 3-0.

Downingtown Library

Mr. Hines explained the capital contribution to Downingtown Library. Mr. Blair motioned to contribute an additional \$15,000 to the Downingtown Library for their capital campaign, second by Mr. Christman. Motion carried 2-0. Mr. Hines abstained due to being a representative on the Downingtown Library Board.

2018 Salary Adjustments

Motion was made by Mr. Christman to approve the 2018 employee wage rates as discussed, second by Mr. Hines. Motion carried 3-0.
