#### **BOARD OF SUPERVISORS**

#### TOWNSHIP PERSONNEL

## Bid Award - Sodium Chloride, Solar Salt and Enhanced Deicer for 2019-2020 Season

The Board reviewed the bid recommendations from Mr. Youtz. Based on lowest bids received, Mr. Youtz, Public Works Director, recommends award of both the sodium chloride and solar salt bids to Eastern Salt Company in the amount of \$52.40/Ton (FOB) and same delivered. Mr. Youtz recommends award of the enhanced deicer bid to Chemical Equipment Labs in the amount of \$62.12/Ton (FOB) and same delivered. Both awards are subject to concurrence from a majority of Consortium members.

Mr. Hines motioned to approve the bid award based on the recommendation of Mr. Youtz, second by Mrs. Abele. Motion carried, 3-0.

### Marshallton Triathlon

Mrs. Abele motioned to authorize the Manager to submit application to PennDOT to close a portion of West Strasburg Road on Sunday, October 6, 2019, second by Mr. Hines. Motion carried 3-0.

## Chester County Watersheds Act 167 Update Process

Mr. Hines motioned to appoint Justin Yaich and Scott Andress as the primary and secondary points of contact for West Bradford Township, allowing the Manager to decide who would be primary and who would be secondary, second by Mrs. Abele. Motion carried 3-0.

The Manager stated that Scott Andress would be primary and he would be secondary.

Mrs. Abele motioned to authorize the Township Manager to select and engage with a financial consulting firm to review the long-range finances of the Township, second by Mr. Hines. Motion carried, 3-0.
