Mr. Hines motioned to award the recycling contract bid to Eagle Disposal for unit price of \$40.00 per ton and total bid of \$64,000.00, second by Mrs. Abele. Motion carried 3-0.

Mr. Hines motioned to ratify the re-submittal for ACT 247 review and advertisement of the newly revised TND-2 Amendment for rescheduled adoption at the December 10, 2019 Board of Supervisor's meeting, second by Mrs. Abele. Motion carried 3-0.

Mr. Hines motioned to ratify the submittal for ACT 247 review and advertisement of the In-Law Suite Amendment for re-scheduled adoption at the December 10, 2019 Board of Supervisor's meeting, second by Mrs. Abele. Motion carried 3-0.

## Verizon Settlement Agreement
