**ORDINANCE NO. 23-06**

**AN ORDINANCE OF THE TOWNSHIP OF WEST BRADFORD, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 415 OF THE WEST BRADFORD TOWNSHIP CODE TITLED "VEHICLES AND TRAFFIC," SECTION 415-7.A TO MODIFY THE SPEED LIMIT ON SHADYSIDE ROAD TO 35 MPH AND SECTION 415-15 TO CREATE STOP INTERSECTIONS AT SHADYSHIDE ROAD AND BROAD RUN ROAD AND BROAD RUN ROAD AND GLENSIDE ROAD.**

**BE IT ENACTED AND ORDAINED** by the Board of Supervisors of West Bradford Township that Chapter 415 of the West Bradford Township Code, titled "Vehicles and Traffic," is hereby amended as follows:

**SECTION 1.** Section 415-7.A, titled, "Speed limits" is amended to delete the following:

<b>Name of Street</b>	<b>Speed Limit (mph)</b>	<b>Location</b>
Shadyside Road	35	From Route 322 to Old Shadyside Road
Shadyside Road	40	From Glenside Road to West Strasburg Road
Shadyside Road	40	From Marshallton-Thorndale Road to Glenside Road
Shadyside Road	40	From Old Shadyside Road to Marshallton-Thorndale Road

**SECTION 2.** Section 415-7.A titled, "Speed limits" shall be amended to add the following:

<b>Name of Street</b>	<b>Speed Limit (mph)</b>	<b>Location</b>
Shadyside Road	35	Entire Length

**SECTION 3.** Section 415-15 titled, "Stop intersections" shall be amended to add the following stop intersections:

<b>Stop Sign on</b>	<b>Direction of Travel</b>	<b>At Intersection of</b>
Broad Run Road	West	Glenside Road
Broad Run Road	East	Glenside Road
Shadyside Road	West	Broad Run Road
Shadyside Road	East	Broad Run Road

**SECTION 4. Severability.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

**SECTION 5. Repealer.** All ordinances or parts of ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 6. Effective Date.** This Ordinance shall be effective five days following enactment as by law provided.
