Although the race will not be run this year, we hope to keep the spirit of the event alive in the form of a fundraising campaign in support of the WBFC and MCT.

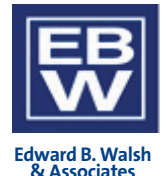

A Letter from the Township Manager



Dear Residents,

I hope you and your family are enjoying a happy and healthy summer season. This year certainly has been unique on many

levels. Shall we talk about something other than COVID-19? How about some 2020 updates on our efforts to preserve, improve and enhance our quality of life and sense of place in West Bradford Township?

Let's start with an update on the progress at the Embreeville site. Due to the nature of the demolition and remediation work, crews were able to continue their work during the shutdown. To date, all 16 buildings have been remediated and demolition has begun. Our environmental consultants continue to monitor progress and perform ground testing to ensure safety and compliance with Federal, State and Local standards. As work continues, we will dedicate some of our attention to the master planning process for the site. We are optimistic that planning will begin in early 2021. As we move forward in developing the master plan for the site, we will be sure to share updates on our Facebook and website pages.

In June, West Bradford adopted our 2020 Comprehensive Plan. This adoption replaces our 2009 Comprehensive Plan. The Plan focuses on the goals and needs of the Township and provides a vision through the year 2030. The Plan aims to continue our progress in preserving natural, historical and cultural features of the Township, while simultaneously accommodating future growth needs.

In July, the Township began the process of updating our 1993 Parks

and Open Space Plan. The new plan is called the Open Space, Recreation and Environmental Resource plan (OSRER). This plan will provide West Bradford Township with a path forward for the continued preservation of our open space and natural resources, the development of future greenways and trails, and the assessment and provision of recreational facilities and programs.

West Bradford is currently in the process of updating our FCC Wireless Communications Ordinance which relates to the placement of minitowers within the Township. While the Federal Government prohibits us from banning these installations, there are tools available to help us regulate their location and aesthetics. The ordinance update allows us to make use of those tools. Our goal is to ensure that, if these minitowers are located within our Township, they blend in with the natural landscape and are hidden to the greatest extent possible. This is the Township's best opportunity to regulate the placement of such structures and preserve our view sheds and scenic roadways.

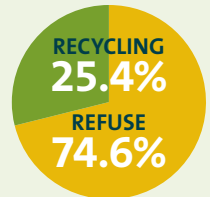
Ultimately, all of these initiatives will dovetail to further enhance the quality of life for residents of West Bradford and protect the sense of community and place that our residents cherish.

Recycle!

COLLECTION FEES



The more we recycle, the less refuse we have to dispose of at the landfill, for a substantial savings to our community. Every dollar saved and earned is retained in the Refuse Fund...helping to keep our collection fee as low as possible.

The Township pays \$67 for each ton of refuse dumped at the landfill and \$40 for each ton of recyclable materials we dispose of. Recycling buyers are much more particular in the products they will process these days. Please follow our recycling guidelines, as it is more important than ever that our materials are clean. Visit our website or call our office if you have questions or need additional information.

In the second quarter of 2020, approximately 25.4% of that collected curbside was recyclable materials. During this three-month period, the Township collected 1,235.34 tons of refuse and 419.64 tons of recyclables, saving us \$11,330.28 in landfill fees.

The Township has a goal of 35% recycling. Please help us reach this goal!

Portable Basketball Nets

Residents should be aware that portable basketball nets should not be placed in or along the roadway. These nets are considered an encroachment in the public right of way and can create a safety concern for others. These nets can also hinder us in our refuse/recycling collection along with winter maintenance operations. If you currently have one, please remove it from the street and place in on your property.

- 1461 Oakwood Road: 3 lots.

- Stargazer Village at Romansville: A 95 single-family home and 39 townhome subdivision at the intersection of Stargazer Road and West Strasburg Road
- The Townes @ Shannon Hill (formerly Mayfair): A 112 townhome subdivision at Boulder Drive
- Chidester: 2 Lots at 1233 Cranberry Lane

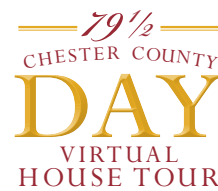
Fall Fun in The Village Of Marshallton— Cancelled

FALL CURBSIDE LEAF AND BRUSH COLLECTION 2020

OCTOBER 21 | NOVEMBER 4 | NOVEMBER 18 | DECEMBER 2

This collection is for leaves and brush only... grass clippings are not accepted! All pick-ups must be scheduled by 2pm the day before the collection date by contacting (610) 269-4174, or by e-mailing pmurdoch@westbradford.org. (For the Nov. 4th collection date, scheduling must be done by Mon., Nov. 2nd, 2pm, as the office is closed on Tuesday for Election Day.) Please specify the number of leaf bags, the number of stick bags, and the number of bundled brush piles.

THERE ARE A FEW SIMPLE RULES TO FOLLOW THAT WILL HELP US TO KEEP THIS SERVICE FREE...

- Bags must be placed curbside by 6am on the scheduled collection days
 - Do not staple or tape bags closed.
 - Bio-degradable bags may be obtained at the Township Office, 1385 Campus Drive, at \$.50 per bag, Mon. through Fri., from 7:00am to 4:30pm.
 - Leaves must be placed in bio-degradable paper collection bags. The bags must be free of plastic, trash, sticks and all other debris. Leaves placed in any other container, including "biodegradable" or "compostable" plastic bags and trash or recyclable totes, will not be collected.
 - Sticks must be placed in bio-degradable paper collection bags or bundled, but can't be mixed with leaves. Bundled brush must not be longer than four feet and must be tied into manageable bundles with a cotton or hemp twine. Branches must not be thicker than four inches. The bundles must be free of plastic, trash and other debris. Branches thicker than four inches will not be collected.
- Residents may also purchase bags sold at local department stores.

Trimings too large for collection?

Shrubbery and tree trimmings up to eight inches in diameter or eight feet in length may be taken to the Lanchester landfill in Honey Brook for a fee. Contact the landfill at (610) 273-3771 for more information.

Planting Trees? Make them Native!

Did you know that fall is the best time to plant trees? When planting trees on your property, consider picking a species that is native to the Northeast. Native trees attract beneficial insects like honeybees, bumblebees, and butterflies that pollinate crops and fruit trees, and serve as food for birds. These beneficial insects eat and pollinate only a few types of plants -- sometimes only a single species. In North America, about 14% of plants feed 90% of the insects. This 14% represents the “keystone species” that keep our food web healthy, especially four kinds of native trees:

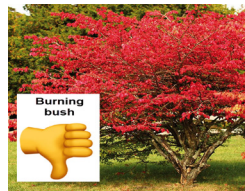
- Oaks
- Poplars
- Willows
- Cherries



non-native trees will not flourish in rising temperatures and wetter conditions that have been associated with climate change. So help your pocketbook and our township ecosystems by planting native trees!



- Barberry (harbors mice, which increases the rate of ticks)
- Autumn olive (rapid grower)
- Norway maples (plant sugar or red maple trees instead).
- Finally, Bradford pear - as much as we love the name - cross-pollinates with related species and displaces native plants in wild areas. 🍷

Land Preservation & Sustainability Committee (LPSC)

Many West Bradford Township residents think about open space when they think about the Land Preservation and Sustainability Committee (LPSC). Conserving open space in order to provide environmental, financial and quality of life benefits to landowners and the community at large is at the heart of the LPSC's mission. Fortunately, many landowners recognize the benefits of land conservation and have put their properties under conservation or agricultural easements. As a result, over 300 acres of open space have been conserved in the three years since the LPSC has been established with additional properties currently under discussion.

But did you know that LPSC's mission also includes sustainability?

LPSC's mission states that it will advise West Bradford's Board of Supervisors on sustainability matters such as "tree planting along stream corridors, educational programs related to planting and maintaining of native species, use of rain gardens, stormwater and erosion controls, composting and reuse of natural materials, removal and control of invasive species, reduction of herbicides, pesticides, and lawn fertilizers; establishing backyard habitat, promoting the naturalization of stormwater basins in existing developments, investigating methods and programs available for recycling, aiding in community reforestation efforts, promoting energy conservation and the use of renewable energies and promoting multi-modal transportation such as trails and public transit."

While the LPSC continues its work on land conservation efforts, it is also focusing on sustainability initiatives such as the ones listed above. To ensure that West Bradford moves toward a more sustainable future together, the LPSC wants to know what residents think is most important when it comes to sustainability.

Watershed Protection Tip



"Topping off" a gas tank after the nozzle clicks can cost you money and pollute our streams! Overfilling causes gas spills that may drain to the storm sewer and nearby streams. And forcing extra gasoline into the tank can decrease engine efficiency and adversely affect the vehicle's emission system.

Free Counseling from APPRISE DURING MEDICARE ANNUAL OPEN ENROLLMENT PERIOD

Medicare counseling (previously offered in person at the township building) by APPRISE counselors is available any time and will continue through the Annual Open Enrollment Period (AOEP), October 15, 2020 - December 7, 2020. In Chester County, APPRISE is part of the Department of Aging. The counseling this year will be by phone or another virtual means. In-person counseling will not be available, but please take advantage of APPRISE services when you have Medicare questions or concerns.

If you are not satisfied with your current Prescription Plan or Medicare Advantage Plan, we can help you evaluate your plan and get information on other plans during AOEP. Throughout the year we can assist with Medicare enrollment and other options to complete your medical coverage.

Remember the "Flushable Four"!

If your property has a grinder pump, only four kinds of materials are permitted to be discharged into the sanitary sewer system...

1. Human waste & toilet paper
2. Food wastes processed through a garbage disposal unit (but not grease)
3. Water from sinks, tubs & dishwashers
4. Water from washing machines

All other materials can damage your grinder pump. This includes paint, adult wipes and baby wipes. Property owners are responsible for any damages caused by the discharge of prohibited materials.

Tips for the Safe Use of Portable Generators

During long-term power outages, many rely on portable generators for emergency power. But many generators are installed and operated incorrectly and pose a real threat to the lives of family, neighbors and utility crews working to restore service.

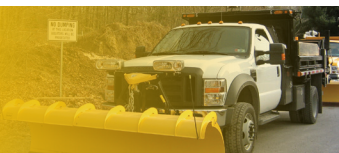
FOLLOW THE TIPS BELOW WHEN INSTALLING AND OPERATING PORTABLE GENERATORS:



- To avoid electrocution, keep the generator dry. Do not use in rain or wet conditions. Operate it on a dry surface under an open canopy-like structure. Make sure your hands are dry before touching the generator.
- Turn off all appliances and lights before you begin operating the generator. Once the generator is running, turn appliances and lights on one at a time to avoid overloading the unit. And don't forget to use safety-tested, shop-type electrical cords designed and rated for heavier, outdoor use.
- Never try power house wiring by plugging the generator into a wall outlet. This practice, known as "back feeding", can lead to the electrocution of utility workers or neighbors served by the same utility transformer. The only safe way to connect a generator to house wiring is to have a qualified electrician install a power transfer switch.
- Shut down your generator correctly. Turn off and unplug all appliances and equipment being powered before shutting off the generator. Drain the gasoline from the generator while it is being stored, and inspect the fuel and oil filters, spark plug, oil level and fuel quality on a regular basis... and before the next power outage!
- Follow the directions supplied with the generator. Incorrect generator use can lead to carbon monoxide (CO) poisoning from the toxic engine exhaust, electric shock, electrocution and fire. Never use a portable generator indoors and never use a portable generator in a garage, carport, basement, crawl space or other enclosed or partially-enclosed area...even with ventilation. Opening doors and windows or using fans will not prevent CO buildup in the home.
- Generators should be at least 20 feet away from buildings. At even 20 feet away air flow patterns may still blow carbon monoxide into homes through attic vents, windows or doors. Keep the generator away from these openings and maintain a working carbon monoxide detector inside the home.

PREPARING FOR SNOWY WINTER ROADS



To make the roads as safe as possible in winter, long hours in very tough conditions are spent by our Road Crew. Please cooperate with them and appreciate the fact that they are doing their best to serve the community and quickly give you the best condition of roads as possible.

Our trucks salt, cinder, and plow over 125 lane miles of roads. We hire extra contractors and maintain stock piles of over 400 tons of anti-skid material. We stock extra parts for plows, salt spreaders, and truck chains. Despite our best efforts, we do have equipment breakdowns during snowstorms. This may delay work on certain routes. Please be patient.

Each operator has a specific route that includes high priority roads and lesser priority roads. Operators will cover their entire route with salt and anti-skid material. This helps to keep the snow and ice from freezing on the surface. After that they begin to plow their route. For minor storms, the entire route may be completed at once. However, if the storm intensifies, only priority routes (usually through roads) will be plowed. Cul-de-sacs and secondary roads will not be done until the main routes can be kept open. As the storm lightens, all roads will be opened. After all roads can be kept open, drivers complete their route by pushing snow back as far as possible on the cartway and clearing the intersections.

BY FOLLOWING THESE GUIDELINES DURING A SNOWSTORM, YOU CAN ASSIST US IN KEEPING THE ROADWAYS OPEN...

- **Don't park cars on a street during a snowstorm as it delays clearing.** Remove all vehicles from streets before the storm and keep them off until the streets are cleared. Not doing so can result in a fine and/or the car being towed.
- **Wait until the roadway is cleared before shoveling your driveway, sidewalk and mailbox area.** If you must clear these areas sooner, Township trucks will likely throw snow back onto your property when plowing the road.
- **Do not shovel snow into the roadway.** Pushing snow from your driveway or sidewalk into the roadway creates a safety hazard and could cause an accident. Property owners may be held responsible for accident damages.
- **Prepare your vehicle for winter driving.** If you are too nervous about driving on snow and ice, don't drive! Share a ride with a neighbor or wait until the roadways are cleared.
- **Check your mailbox.** We are not responsible for mailbox damage unless we actually hit the mailbox with a truck or plow blade. Heavy snow thrown from highway plows will break mailboxes and rotted posts and you are responsible for these repairs.
- **The Township does not plow private roadways, roadways not dedicated to the Township and most State-owned roadways.** Bradford Avenue, Brandywine Drive, Glenside Road (from Beacon Hill Road into Downingtown), Camp Linden Road, Marshallton-Thorndale Road, Northbrook Road, Romansville Road, Downingtown Pike (Route 322), Embreeville Road, Stargazers Road, West Strasburg Road and Route 162 (from W. Strasburg to the Township line) are maintained by the Commonwealth. Please contact the Pennsylvania Department of Transportation at (610) 436-2091 to report snow removal concerns at these roadways.

We thank you for continued patience and understanding while we work to keep our roads safe during the winter season. 🍂
