### OPTION #1 [ FREE ]

#### OPTION #1: Drop-Off at the Municipal Campus (FREE!)

Trees and greens may be dropped-off at the Municipal Campus, 1385 Campus Drive, at any time from December 25 to January 31. Stands, ornaments and plastic bags must be removed so that the materials can be shredded into mulch. Please note that wreaths are not accepted.

If a regularly-scheduled refuse, large item or recycling collection day falls on an observed holiday, collection for that day will be rescheduled for the Wednesday of that holiday week.

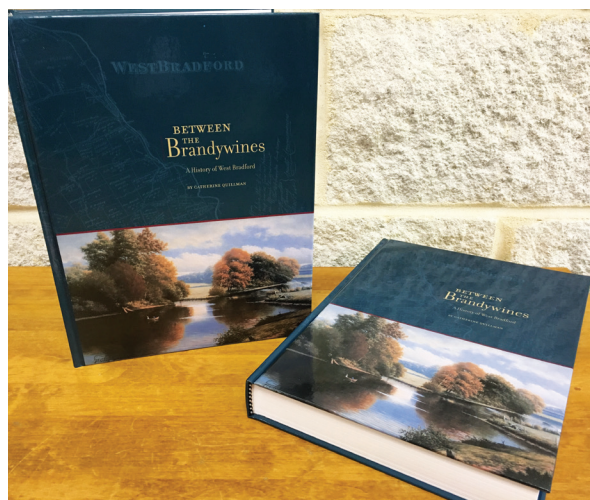

### INVASIVE VINES: HOW AND WHEN TO MANAGE THEM

West Bradford Township is blessed with an abundance of woodlands. These woodlands improve air quality and provide a cooling effect compared to the more developed regions around us. They also provide a connected habitat corridor in, through, and around the various developments and homes in the Township. For this reason, protecting the trees on your property, whether there are two or 102, is an important task for every homeowner. Primary threats to our local trees are the numerous invasive vines found throughout the woodlands. Often these start along the woodland edge before encroaching further in, so homeowners that back up to woodlands are an important factor in the battle against invasive vines.

Vines are so common in woodlands that residents often don't recognize that the vines don't belong. When vines are left unchecked, they end up girdling the tree, shading out the

leaves, and eventually strangle the tree to death. This increases the risk of property damage, power outages, and other impacts of dead trees falling in windstorms and other weather events. Vines can be as thick as tree trunks on their own and to see them wrapped around the trunk and branches of a tree illustrates why they are such a threat to healthy trees.

An additional negative impact of invasive vines is the creation of an entry point for the sun when a tree falls in the woods. This may not seem like a bad thing, but in the middle of a woodland, any new source of light often leads to the spread of other invasives, which sprout up quickly and then outcompete the native undergrowth. Invasive plants are often ignored by native wildlife and are then left unchecked to spread further into the woodlands.

The best time of year to work on combating invasive vines is the

winter and early spring when the undergrowth has died away and it is relatively easy to work your way along the woodland edge and through the interior. The simplest method of stopping vine growth is to cut through the vine several feet off the ground and then again a couple feet higher. By removing a chunk of the vine and not just cutting straight through, the chance of the vine sprouting and reconnecting is eliminated. The vines can then be left to die and rot and will eventually fall out of the tree. To avoid injury, do not attempt to pull large vines out of your trees. Cut them and leave them.

Annual review of the trees and woodlands on your property will help ensure vines don't have a chance to overtake your healthy trees. Managing them will benefit you, your neighbors, and area wildlife, so get outside this winter and go for a walk. Just don't forget your clippers or saw! ✂

## Too Much Salt: Bad for You, Bad for the Brandywine

Thank you to residents who completed our sustainability survey! You requested information on local water issues, so this article discusses winter water management. We'll report full survey results soon.

Winter weather brings slippery roads and sidewalks. West Bradford Township alone uses 500-800 tons of salt (sodium chloride) each winter to keep our roads safe. As much or more is used by PennDOT on state roads in our township. Some of that salt finds its way into our streams and eventually the Brandywine Creek through runoff. Some also enters groundwater through infiltration. According to a 2017 Smithsonian article and other scientific sources, at

high enough levels, these chemicals can kill insects and other organisms that fish rely on, and even harm the fish themselves. De-icing chemicals that reach the Brandywine also become troublesome to Aqua Pennsylvania's water treatment plant in East Bradford, which provides drinking water to some West Bradford residents.

It is important we keep our sidewalks and driveways safe. But with over 13,000 residents in the township, the amount of chemicals applied to surfaces adds up. Studies have also shown commercially available ice-melting chemicals can be harmful to concrete and asphalt surfaces as well as to pets and gardens.

### TRY THESE MORE ENVIRONMENTALLY-FRIENDLY ALTERNATIVES TO SODIUM CHLORIDE:

- Forgo the melting altogether and apply sand or ashes from the fireplace to help with traction.
- Use either sugar beet juice or vinegar, two liquids that lower the freezing temperature of water and therefore 'melt' ice and snow.
- Consider using calcium chloride instead of sodium chloride because it's less harmful than other salts to the environment.

Also consider helping reduce the need for road salt by only driving when absolutely necessary during freezing or snowy conditions. Whether on your property or in your car, stay safe and warm this winter! ❄



## Proper Placement of Mailboxes

West Bradford Township takes every precaution to avoid damaging mailboxes during snow removal operations.

### MAILBOX PLACEMENT GUIDELINES TO HELP REDUCE THE CHANCE YOUR MAILBOX IS DAMAGED THIS WINTER:

- Mailboxes should be located 2' from the edge of pavement to provide adequate clearance at an uncurbed roadway.
- The mailbox face should be located 8" behind the curb face at a curbed roadway.
- Mailboxes should be installed on the side of your driveway away from approaching traffic. This will lessen the likelihood of a plow strike, and minimize the shoveling needed to clear the area around the mailbox.

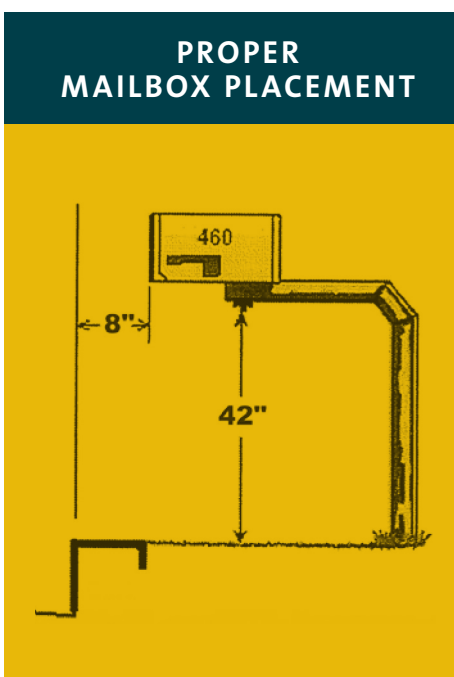
The Township is not responsible for damage caused by snow or ice that is thrown from the snowplow blade. Standard mailboxes and posts are replaced by the Township only if either or both are actually struck by the plow and if these are installed to the specifications of the US Postal Service.

### THE USPS REQUIRES THAT:

- the mailbox be installed at least 42" above the roadway surface; and,
- mailbox posts not exceed 4" by 4" for wooden posts, and a 2" diameter for steel pipe posts. Larger posts are deemed "deadly fixed objects", and are not permitted within the right-of-way.

The Township neither replaces nor reimburses residents for custom mailboxes or ornate posts.

## Snowy Winter Roads

Prior to snow beginning to fall and when conditions warrant, the Township applies a salt brine mixture to the roadway surface to prevent the formation of ice. Once snow begins to fall, granular salt is applied. Trucks then work to plow the roadways, following specific routes that clear emergency routes and high-priority roads first. Cul-de-sacs and other secondary roads are not plowed until all emergency routes and high-priority roads are passable.

Our Public Works team will always do their very best to keep roadways as clear as possible, as quickly as possible, but we need your help!

#### WHEN THE FIRST SNOWFLAKES BEGIN TO FALL, PLEASE REMEMBER TO...

- **Remove vehicles from the roadway until the roadway is cleared.** Vehicles parked on the roadways during winter weather events will be ticketed. Vehicles parked on emergency routes may be ticketed and towed.
- **Wait until the roadway is cleared before shoveling your driveway, sidewalk and mailbox area.** If you must clear these areas sooner, please know Township trucks will likely throw snow back onto your property when plowing the road.
- **Do not shovel snow into the roadway.** Pushing snow from your driveway or sidewalk into the roadway creates a safety hazard and could cause an accident. Property owners may be held responsible for accident damages.
- **Prepare your vehicle for winter driving.** And if you are too nervous about driving on snow and ice, don't drive! Share a ride with a neighbor or wait until the roadways are cleared before traveling.

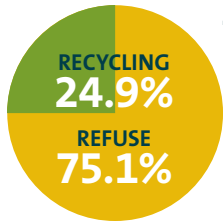
The Township does not plow private roadways, roadways not dedicated to the Township and most State-owned roadways. West Strasburg Road, Marshallton-Thorndale Road, Northbrook Road, Romansville Road, Downingtown Pike (Route 322), Embreeville Road, Bradford Avenue, Brandywine Drive, Glenside Road (from Beacon Hill Road into Downingtown), Camp Linden Road and Stargazers Road are maintained by the Commonwealth. Please contact the Pennsylvania Department of Transportation at (610) 436-2091 to report snow removal concerns at these roadways.

We thank you for continued patience and understanding while we continue to keep our roads safe during this winter season. ☺



## Recycle!

### HELP THE ENVIRONMENT & CONTROL COLLECTION FEES



The more we recycle, the less refuse we have to dispose of at the landfill, for a substantial savings to our community. Every dollar saved and earned is retained in the Refuse Fund... helping to keep our collection fee as low as possible!

The Township now pays \$67 for each ton of refuse dumped at the landfill and \$40 for each ton of recyclable materials we dispose of, an increase from what we paid a year ago. Buyers for these materials are much more particular in the products they will process.

It is more important than ever that our materials are clean. Please continue to follow the guidelines on our website or call our office if you need additional information.

In the third quarter of 2020 approximately 24.9% of that collected curbside was recyclable materials. During this three-month period, the Township collected 1,212.53 tons of refuse and 402.69 tons of recyclables, saving us \$10,872.63 in landfill fees. ♻️

## Important Tips from the Refuse & Recycling Department

1. The last leaf and brush collection of 2020 will be offered on December 2. To schedule a pick-up, please contact the Township by 2pm on December 1 at (610) 269-4174, or e-mail [pmurdoch@westbradford.org](mailto:pmurdoch@westbradford.org).
2. During and after snowstorms, please remove refuse and recyclable totes from the side of the roadway as soon as possible after they are emptied.
3. Do not place totes atop snow piles. The collection vehicle's arm can't grab a toter that's not on the ground!
4. Do not park in cul-de-sacs on your recycle or trash pickup day.
5. Place totes at least four feet from any objects, including vehicles, mail boxes, trees and utility poles. The collection vehicle's lifting arm may not be able to grab a toter if it is too close to another object.
6. Per Township Ordinance, please do not put out your recyclable toter on refuse day, or your refuse toter out on recyclable day.

## Remember the "Flushable Four!"



If your property has a grinder pump, only four kinds of materials are permitted to be discharged into the sanitary sewer system...

1. human waste & toilet paper;
2. food wastes processed through a garbage disposal unit (but not grease);
3. water from sinks, tubs & dishwashers; and,
4. water from washing machines.

All other materials can damage your grinder pump, and this includes all varieties of adult and baby wipes. Property owners are responsible for any damages caused by the discharge of prohibited materials.

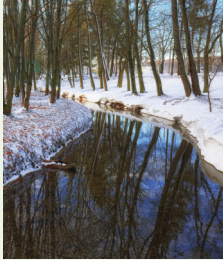
And while all recipients are asked to make a modest donation toward the cost of their daily lunch, Meals on Wheels will never deny a meal to those unable to make a donation.

## Watershed Protection Tip

### CREEK-FRIENDLY YARD CARE TIPS FOR WINTER

Just because it's winter, it doesn't mean there's no yard work! There are plenty of things to do that will help reduce the need for pesticides next spring.



- Spray dormant oil on the bark surfaces of pest-prone ornamental trees and shrubs. Dormant oil is non-toxic and works to kill the eggs of wintering insects. Check product labels for a list of sensitive plants, such as azaleas. And be sure not to spray on blue-needled conifers.
- Spray a leaf protectant on hollies, rhododendrons and other broadleaf evergreen plants to protect against winter moisture loss. Spray early in the winter season when temperature is above freezing.
- Overseed bare spots in your lawn in late winter (i.e., March). This will increase turf density before weeds have time to germinate.

This Watershed Protection Tip is part of West Bradford Township's ongoing effort to provide public education on stormwater management and the protection of our environment.
