APPLICATION FOR CONNECTION TO SANITARY SEWER
MINIMUM SUBMISSION REQUIREMENTS

Minimum information required for initial submission:

- ☐ Completed Application for Connection to Sanitary Sewer form with required fees
- ☐ Site Plan showing all existing and proposed improvements and the proposed sewer connection. Fully engineered site plans are required for all connections requiring a pump. All site plans must at a minimum include the location of the features listed below, with additional information for each as noted. Please write "N/A" next to any features which do not exist on the project parcel.
 - ☐ Dimensions of property lines
 - ☐ Dimensions of existing and proposed buildings
 - ☐ Type of water supply
 - ☐ Stormwater management facilities, including drainage swales, if present.
 - ☐ Driveways and parking areas
 - ☐ Dimensions of any existing or proposed easements and rights-of-way
 - ☐ Depth, materials and construction details for all proposed sewer connection components.
 - ☐ Water bodies, wetlands and/or floodplains on the project parcel(s), if present.
 - ☐ Existing on-lot sewage system tank(s) and disposal area to be abandoned.

Four (4) paper copies and one (1) electronic copy of all plans and accompanying documents must be submitted. All plans must be folded and electronic submissions must be provided on a compact disc or flash drive.

Additional Information Required:

The requirements below may not be applicable to all projects or are items which may be addressed after initial application submission. Please check items as applicable if addressed in the initial submission.

- ☐ DEP Act 537 approval. Verification from the Township that the project parcel is in the DEP approved Act 537 public sewer service area has been received, or written verification from DEP is attached that no Sewage Planning Module will be required for the proposed sewer connection. Required prior to permit issuance.
- ☐ Tapping Fees. All current tapping fees must be paid prior to permit issuance.
- ☐ PennDOT Highway Occupancy Permit. Required for all work within the right-of-way of a State road.
- ☐ West Bradford Township Road Occupancy Permit. Required for all work within the right-of-way of a Township road.
- ☐ Completed Grinder Pump Easement Agreement. Required for all proposed grinder pump connections prior to permit issuance. Please contact the Township for a form agreement copy.
- ☐ Completed Grease Trap Operation and Maintenance Agreement. Required for all uses involving food preparation of other commercial uses for which a grease trap is required prior to permit issuance. Please contact the Township for a form agreement copy.

Additional requirements as may be specific to a particular project will be identified in Township review of a complete initial submission, if not already included in the submitted permit package.
