A Note from the Township Manager, Justin Yaich

As you may know by now, the Township Board of Supervisors has unanimously approved the terms of settlement with Embreeville Redevelopment. The terms of settlement will allow the Township to purchase the 200-acre property, less approximately 5 acres with existing buildings located thereon, for a purchase price of \$22.5 Million Dollars. The purchase price is based on an appraisal of the property that the Township commissioned.

The Settlement Agreement would require the Developer to demolish all buildings on the portion of the property proposed to be acquired by the Township, properly abate the asbestos in such buildings and obtain Act 2 environmental clearance from the Pennsylvania Department of Environmental Protection. It would allow Developer to develop the SPCA Parcel with no more than 33 single-family detached dwellings based on a land development plan to be filed and subsequently reviewed by the Board.

In order to fund the purchase price of the property, the Board will enact a real estate tax of 1/2 mill pursuant to the authority in the Local Tax Enabling Act. The Board would also obtain bond financing and use revenue generated from the Township's open space tax to pay for a portion of the property.

Originally, it was believed that a 1 mill tax would be required to complete the deal.

However, based upon further review and refinement of our budget, in addition to being awarded up to \$5 million in County open space funding, we comfortably believe we can make the deal work with a ½ mil tax. That would equate to a property assessed at \$100,000.00 paying \$50.00.

The Township will continue to vigorously pursue outside funding from the State and any other outside agency to further drive down the burden placed on the residents of West Bradford Township.

As we embark on this new initiative, we welcome your input and seek your support. Together, we can ensure that the next generation is able to experience the beauty of West Bradford, just as the generations before us have.

I wish all of you and your loved ones a very happy holiday season and may 2020 be filled with health, happiness, and prosperity. 🍀

Land Preservation and Sustainability Committee

Since West Bradford Township (WBT) residents approved the Open Space referendum in November 2017, 126.5 acres of open space have been approved for conservation by the LPSC and Township Supervisors, demonstrating that WBT landowners support the benefits of open space for their families and the community at large*. Interest among landowners to conserve their land is high and continues to increase. The Township is in discussions with many landowners who understand the benefits of conserving open space for their families and the entire community and want to leave an enduring legacy for generations to come. In addition to helping conserve open space in WBT, the LPSC is responsible for educating residents on how they can become more sustainable in their own day-to-day practices.


Recycle! Help The Environment and Control Collection Fees

The more we recycle, the less refuse we have to dispose of at the landfill, for a substantial savings to our community. Every dollar saved and earned is retained in the Refuse Fund—helping to keep our collection fee as low as possible.

The Township pays \$65 for each ton of refuse dumped at the landfill and \$25 for each ton of recyclable materials we dispose of. The markets for these materials have significantly changed and buyers are much more particular in the products they will process.

It is more important than ever that our materials are clean, so we request that you continue to follow our guidelines. Visit our website or call our office if you have questions or need additional information. In the third quarter of

2019 approximately 24.8% of that collected curbside was recyclable materials. During this three-month period, the Township collected 1,109.38 tons of refuse and 365.72 tons of recyclables, saving us \$14,628.80 in landfill fees. West Bradford Township has a goal of 35% recycling. Please help us reach this goal!

Proper Placement of Mailboxes

West Bradford Township takes every precaution to avoid damaging mailboxes during snow removal operations. The Township is not responsible for damage caused by snow or ice that is thrown from the snowplow blade. Standard mailboxes and posts are replaced by the Township only if either or both are actually struck by the plow and if these are installed to the specifications of the US Postal Service.


MAILBOX PLACEMENT GUIDELINES TO HELP REDUCE THE CHANCE YOUR MAILBOX IS DAMAGED THIS WINTER:

- Mailboxes should be located 2' from the edge of pavement to provide adequate clearance at an uncurbed roadway.
- The mailbox face should be located 8" behind the curb face at a curbed roadway.
- Mailboxes should be installed on the side of your driveway away from approaching traffic. This will lessen the likelihood of a plow strike, and minimize the shoveling needed to clear the area around the mailbox.

THE USPS REQUIRES THAT:

- The mailbox be installed at least 42" above the roadway surface; and,
- Mailbox posts not exceed 4" by 4" for wooden posts, and a 2" diameter for steel pipe posts. Larger posts are deemed "deadly fixed objects," and are not permitted within the right-of-way.

The Township neither replaces nor reimburses residents for custom mailboxes or ornate posts. If you believe a properly-installed mailbox or post was struck by a Township vehicle, please contact the Township at (610) 269-4174. 📞



Important Reminders and Tips from the Refuse & Recycling Dept.

- The last leaf and brush collection of 2019 will be offered on December 4. To schedule a pick-up, please contact the Township by 2pm on December 3 at (610) 269-4174, or e-mail pmurdoch@westbradford.org.
- During and after snowstorms, please remove refuse and recyclable toters from the side of the roadway as soon as possible after they are emptied.
- Do not place toters atop snow piles. The collection vehicle's arm can't grab a toter that's not on the ground!
- Do not park in cul-de-sacs on your recycle or trash pickup day.
- Place toters at least four feet from any objects, including vehicles, mail boxes, trees and utility poles. The collection vehicle's lifting arm may not be able to grab a toter if it is too close to another object.
- Per Township Ordinance, please do not put out your recyclable toter on refuse day, or your refuse toter out on recyclable day.

Snowy Winter Roads

Prior to the snow beginning to fall, and when conditions warrant, the Township applies a salt brine mixture to the roadway surface to prevent the formation of ice. In addition, once snow begins to fall, granular salt is applied. Trucks then work to plow the roadways, following specific routes that clear emergency routes and high-priority roads first. For safety reasons, cul-de-sacs and other secondary roads are not plowed until all emergency routes and high-priority roads are passable. Our Public Works team will always do their very best to keep roadways as clear as possible, as quickly as possible, but we need your help!

WHEN THE FIRST SNOWFLAKES BEGIN TO FALL, PLEASE REMEMBER TO...

- Remove vehicles from the roadway until the roadway is cleared. Vehicles parked on the roadways during winter weather events will be ticketed. Vehicles parked on emergency routes may be ticketed and towed.
- Wait until the roadway is cleared before shoveling your driveway, sidewalk and mailbox area. If you must clear these areas sooner, please know Township trucks will likely throw snow back onto your property when plowing the road.
- Do not shovel snow into the roadway. Pushing snow from your driveway or sidewalk into the roadway creates a safety hazard and could cause an accident. Property owners may be held responsible for accident damages.
- Prepare your vehicle for winter driving. And if you are too nervous about driving on snow and ice, don't drive! Share a ride with a neighbor or wait until the roadways are cleared before traveling.

The Township does not plow private roadways, roadways not dedicated to the Township and most State-owned roadways. West Strasburg Road, Marshallton-Thorndale Road, Northbrook Road, Romansville Road, Downingtown Pike (Route 322), Embreeville Road, Bradford Avenue, Brandywine Drive, Glenside Road (from Beacon Hill Road into Downingtown), Camp Linden Road and Stargazers Road are maintained by the Commonwealth. Please contact the Pennsylvania Department of Transportation at (484) 340-3200 to report snow removal concerns at these roadways. We thank you for continued patience and understanding while we work to keep our roads safe during the winter season. 🍂

The “Flushable Four”

If your property has a **grinder pump**, only four kinds of materials are permitted to be discharged into the sanitary sewer system:

- human waste and toilet paper
- food wastes processed through a garbage disposal unit (*but not grease*)
- water from sinks, tubs and dishwashers
- water from washing machines

All other materials can damage your grinder pump, and this includes **all varieties of adult and baby wipes.** Property owners are responsible for any damages caused by the discharge of prohibited materials.

WATERSHED PROTECTION TIP: **Creek-Friendly Yard Care** **Tips for Winter**


Just because it's winter, it doesn't mean there's no yard work! There are plenty of things to do that will help reduce the need for pesticides next spring.

- Spray dormant oil on the bark surfaces of pest-prone ornamental trees and shrubs. Dormant oil is non-toxic and works to kill the eggs of wintering insects. Check product labels for a list of sensitive plants, such as azaleas. And be sure not to spray on blue-needled conifers.
- Spray a leaf protectant on hollies, rhododendrons and other broadleaf evergreen plants to protect against winter moisture loss. Spray early in the winter season when temperature is above freezing.
- Overseed bare spots in your lawn in late winter (i.e., March). This will increase turf density before weeds have time to germinate.

This Watershed Protection Tip is part of West Bradford Township's ongoing effort to provide public education on stormwater management and the protection of our environment.


Temple-Webster-Stoner House **15” x 20½ Art Prints** **by Richard Bollinger**

West Bradford Township is pleased to offer this limited edition print of one of the most historical structures in our community. Tucked into a hillside along the banks of the idyllic Broad Run Creek, the Temple-Webster-Stoner house is one of the region's finest aesthetically unaltered examples of “Penn Plan” architecture. Constructed in the early 1700's from local fieldstone, the house shared property with an adjacent mill for many years. The Temple-Webster-Stoner house was placed on the National Register of Historic Places in 1973. Produced on the finest quality acid-free paper, each print has been personally signed and numbered by the renowned artist Richard Bollinger. Each print is \$75, 15” x 20 ½” unframed, and is available for purchase at the Township Building.

Do You Know? ANSWER

After World War II, when development of high rise apartments was booming in the Soviet Union, black poplar trees were planted in huge numbers, particularly in Moscow. They were the fastest growing, most enduring shade trees at the time. The only problem is that after 15 plus years the female trees produce large amounts of seeds, which appear as fluff or down. This fluff, called pukh in Russian, creates a multitude of annoying problems.

When the Bradford Glen development was built, the developer planted a large number of the black poplars as street trees. A number of years later the same problems that Moscow endures were evident in Bradford Glen. At that time, the township, the homeowner's association and the developer joined forces and removed approximately 630 of the offending trees and created a new street tree scape with a variety of more appropriate types of trees.
