**REVIEW/APPROVE MINUTES**

Draft minutes prepared for the August meeting were approved with one minor edit.

**COMPREHENSIVE PLAN:**

Bob Portnoy gave an update on progress being made on the township's comprehensive plan. A draft plan is expected to be ready for review by the end of the calendar year.

**UPDATE ON LAND PRESERVATION PLAN:**

Rob Daniels and John Goodall discussed progress being made on Chapters 1 and 3 of the Land Preservation Plan. Brandywine Conservancy plans to have Chapters 1 and 3 and their related appendices reviewed and approved by the end of September.

**UPCOMING PUBLIC OUTREACH EVENTS:**

Bob Portnoy confirmed there will be a LPSC exhibit at the Marshallton Triathlon in early October. Several committee members agreed to attend and staff the exhibit. Lyle Frederick suggested that LPSC host another event/dinner at Temenos this winter to provide information on LPSC activities, the Broad Run program, and land preservation options and opportunities for West Bradford property owners. Committee members agreed; Lyle will begin making inquiries and planning the event. Committee members also agreed to provide an exhibit at West Bradford Day on May 18, 2020. Lastly, a ribbon-cutting event will be planned for the opening of the new Sawmill Road trail next spring.

**1993 PLAN AND GREENWAYS TRAILS & GATEWAYS TASK FORCE DOCUMENT**

John Goodall led a discussion about revising and updating these two plans in 2020 once the Open Space Plan has been completed. For now, committee members have been asked to review both plans and identify items from the plans that should be captured in the updated Open Space Plan.
